

## Introdução

*Espacenet* é a base de dados do Escritório Europeu de Patentes (EPO), que possui mais de 120 milhões de documentos de escritórios de patentes governamentais pertencentes a mais de 100 países.

Atualmente, há uma nova versão, conhecida como *Espacenet* “beta”.

## Introdução

Embora o EPO tenha lançado uma nova interface de busca em 2019 com novos recursos, a interface antiga (“*classic*”) ainda está disponível.


## Interface

A nova interface de busca da base *Espacenet* permite uma busca interativa, por meio de preenchimentos e seleções simples.

É de fácil visualização e interação.

Permite a alteração dos parâmetros nos campos de busca de maneira simultânea à visualização das figuras dos documentos.

Permite a visualização de gráficos.



É possível baixar os documentos buscados.

Permite baixar a folha de rosto das patentes que constam de uma lista de resultados da busca.

Estão acessíveis as funcionalidades tradicionais da antiga interface da base *Espacenet* como a tradução de documentos e a busca por classificações.



## Interface

No campo de busca, as palavras podem ser digitadas livremente, apertando-se a “lupa” para fazer a busca.

Se não for colocado nenhum operador entre os termos, o sistema entende como se houvesse o “AND”.

Podem ser utilizadas várias informações diferentes, e diferentes operadores.



- texto nas diversas partes do documento (termos para a busca);
- números do documento (publicação, prioridade, etc);
- datas (depósito, publicação, etc);
- nomes (depositante e inventor); e
- classificações (IPC ou CPC)



8 A very important advantage of the present invention is well shown in Figure 3 of the drawing wherein it will be seen that the seat 2 in the top face of the saucer and the seat defined by the circular rib on the bottom of the saucer are so proportioned that a plurality of units made up of a cup and saucer may be assembled in a vertical stack with a cream jug on each saucer and disposed in a stable condition. When thus stacked, the cups and the jugs may be empty or filled with a liquid, and, in either condition, a waiter may conveniently remove from the top of the stack a unit consisting of a saucer, cup and cream jug without losing time to assemble the three members into a unit.





## **Considerações Finais e Dicas**

As bases de dados descritas apresentam campos de busca similares, assim como caracteres de truncagem (\*) e operadores lógicos (AND e OR).

O operador lógico “AND” deve ser utilizado para combinar características distintas e o “OR” para sinônimos.

Os operadores “AND NOT” e “NOT”, devem ser usados com extrema cautela e por este motivo não estão sendo introduzidos neste guia básico.

Nas bases em que se utiliza apenas \* (asterisco) como caractere de truncagem, deve-se observar qual a real necessidade de utilizá-lo e a melhor forma.

## Considerações Finais e Dicas

A truncagem utilizando \* (asterisco) deve ser usada de forma inteligente, pois pode trazer resultados indesejados. Exemplo: para uma busca na área de telefonia, a expressão “telef\*” trará documentos relativos a teleféricos.

Por exemplo, se o objetivo for recuperar termos relacionados a mosquitos e mosquiteiros, com terminações de tamanhos diferentes, numa busca em português no Latipat, algumas opções seriam:

- a) mosquito, mosquitos, mosquiteiro      usar mosquit\*;
- b) para plural ou singular      usar ? no final: mosquito? (mosquito ou mosquitos)

- c) para masculino ou feminino      usar # no final: mosquiteir# (mosquiteiro ou  
mosquiteira)      →
